## **TERMS & CONDITIONS AGREEMENT / RELEASE (Please read carefully)**

I hereby certify that I am an independent contractor, assuming all responsibility for myself as a result of my participation in Susquehanna Speedway Park (hereafter known as "SSP") events. I am not an employee, servant or agent of SSP. In consideration of acceptance by SSP of this application, the undersigned agrees to abide by all rules and regulations of SSP as to conduct. I agree not to libel or slander the speedway, its owners or its personnel in any way that is harmful to its business or persons and I am solely responsible for all written and verbal communication produced by me. A Media Credential Card grants access to the authorized Card Holder only. All other persons must pay entrance fees via Ticket or Pit Pass Gate. Appropriate fluorescent Safety Vests (identifying media personnel) should be worn on the infield and pit area at all times.

**Print / Photos** - The Susquehanna Speedway Park Media Accreditation Terms and Conditions include (but are not limited to) the provision that any stories produced and/or still photographic taken at each event will be used for media purposes only and not for commercial use. Media credentials are not intended for those who sell photos or images for purposes other than editorial coverage. Credentials WILL NOT be issued to those involved in commercial ventures, unless specially approved, written consent is obtained from SSP.

**Television / Video / Broadcast** - SSP maintains the exclusive right to film/broadcast Susquehanna Speedway Park events. SSP reserves the right to restrict access to any video or audio recording devices at any time without notice. Prior approval and notification of presence is required for videotaping in all cases.

The undersigned understands and agrees that he/she and their beneficiaries, executors and assigns will be entitled to the benefits of the Insurance Policy procured by SSP for accidental injuries or death which occur as the result of external, violent and visible means, sustained in SSP events. The coverage of the said policy shall constitute the limit of liability of SSP for such injuries occurring to the undersigned in any SSP event, provided proper notification of such occurrence is filed with SSP management prior to that person leaving the speedway property. **The undersigned fully understands that a racecar exposes him or her to risks serious bodily injury or death. The undersigned voluntarily assumes these risks.**
